GENERAL OVERVIEW OF ROLE

The post holder will be responsible for the development and integration of UK-wide substance misuse specialist pathways and partnerships within a highly specialised military veterans psychological trauma service. The role is primarily developmental and strategic, focusing on building sustainable internal capability and external networks. The post-holder will lead on our substance misuse strategy, ensuring that pathways and partnerships are evidence-based, trauma-informed, veteran-centric and aligned with NICE approved best practice.

This Band 7 role is open to candidates from a range of professional backgrounds, including but not limited to nursing, psychology, occupational therapy, and psychotherapy. The successful candidate will demonstrate a strong understanding of medical, psychological and social approaches to the treatment substance misuse.

MAIN DUTIES AND KEY RESPONSIBILITIES

- Scoping, design and implementation of specialist substance misuse pathways.
- Develop service protocols, referral criteria and joint working agreements for veterans presenting with co-occurring substance use and PTSD / C-PTSD.
- Ensure alignment with NICE guidance and PTSD / C-PTSD care models.
- Deliver training and specialist advice/consultation on substance misuse to colleagues across the service.
- Participate in the development and implementation of clinical pathways for veterans, ensuring equitable access to care across all regions.
- Support the transition of service users to external specialist services where appropriate.
- Map and establish formal partnership arrangements with UK-wide statutory and third sector substance misuse providers including veteran specific organisations.



- Maintain up-to-date knowledge of relevant legislation, policies, and best practices in substance misuse and mental health.
- Provide expert clinical consultation to MDT colleagues regarding co-morbid substance misuse and trauma presentations.
- Support clinical formulation and risk management planning within the MDT.
- Maintain up-to-date knowledge of evidence-based interventions and approaches.
- Lead the integration of substance misuse awareness and assessment into the service's UK-wide clinical pathways.
- Design and deliver training and professional development programmes in the assessment and management of co-occurring substance misuse.
- Provide specialist supervision and mentoring to designated staff where substance misuse is a factor in clinical presentations.
- Develop accessible clinical resources and training materials for ongoing internal use.
- Negotiate referral and care coordination agreements, ensuring seamless transitions
- Contribute to audit, evaluation and service improvement projects.
- Support research and innovation.
- Provide specialist input to policy development, business cases and funding bids as required.
- Maintain active professional registration and CPD portfolio.
- Work within professional code of conduct and local clinical governance policies.
